**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The LAND TRANSPORTATION OFFICE Region IV-A, through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder contract:

Name of Contract : Construction of LTO Region IV-A Motor Vehicle Inspection Station  
 Location : Brgy. San Benito, Alaminos Laguna  
 Brief Description : Building Construction, Fencing and Site Development  
 Approved Budget for the Contract (ABC) : ₱24,500,000.00  
 Contract Duration : 180 Calendar Days

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as in the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).
